The Youth CSI Forensic Science Class is a Workforce Development Initiative. This training program was established as a way to increase equity and skills levels of students so they can compete for high-paying jobs. This Workforce Development Program is supported by the Plant City Police Department as part of its community outreach program.

The Primary Trainer is Forensic Laboratory Certified and is Certified through the International Association For Identification. Completion of the Training Program can only be achieved when the student successfully completes all components and modules of the Forensic Latent Print Examiner Training Program. This is a task-oriented training program rather than time-oriented, which means that a date for completion of this training program cannot be determined but one should expect a maximum period of 104 weeks.

Students must be of Junior High School (grades 7<sup>th</sup> thru 10<sup>th</sup> grade) and will be evaluated for acceptance into CSI Forensic Program. CSI applicants with issues or incidents on juvenile/adult records will not be accepted. The curriculum (STEM) is school district approved. CSI Forensic Program requires extensive reading, lecture sessions, and attention to detail.
